- Has solid ethics, strong business/community involvement, and a strong belief in the purpose and goals of the Chamber.
- Attendance & Participation—we need you engaged in our board and committees! Is available to attend the meetings, retreat/orientation. Is willing to serve as a board liaison for a Chamber committee.
- Representation & Positive Presence—we need leading ambassadors within our community! Social media and public comments should reflect positively on Harris County, the Chamber of Commerce and fellow Chamber members.
- Strategic Planning & Implementation—we need big thinkers and forward-moving business leaders.
- Recruitment & Retention—we need your help in growing and retaining membership.
- Financial resources—we need your support with Chamber events and resources in fundraising events.
- Confidentiality & Board member agreement — must be willing to sign and adhere to as a Board member.

The 2021 Chamber Board slate will be presented for approval by members at the Annual Membership Meeting on January 19, 2021. Those approved must commit to participating in a one-day strategic planning session (date TBA).
